

Major General Mark D. McCormack Biography February Guest Speaker

Maj. Gen. Mark D. McCormack Commanding General, 28th Infantry Division

On 20 June 2020, Maj. Gen. Mark McCormack. assumed command of the 28th Infantry Division, Pennsylvania Army National Guard, an Infantry Division consisting of 14,000 Soldiers, four major subordinate commands and 23 battalions, stationed in over 100 communities in Pennsylvania, Ohio, Virginia, West Virginia, Connecticut, New Jersey, and Tennessee and equipped with over 5,500 tracked and wheeled vehicles and over 60 attack, utility, and cargo rotary wing aircraft. He is responsible for the execution of readiness programs with special emphasis on strength management, personnel, intelligence, training, logistics, facilities and communications readiness.

General McCormack was commissioned in 1988 through the Reserve Officer Training Corps program at Fort Benning, Georgia. McCormack assumed command of the 281st Personnel Detachment and led a detachment to Operation Joint Endeavor in Germany. He served as the 28th ID Support Command S1 and as personnel service officer and J1 at JFHQ. He served as Deputy Commander, Headquarters, 213th Area Support Group in support of Operation Iraqi Freedom and then as commander of the 213th Regional Support Group in Allentown. Prior to his present assignment, he served as Deputy USPFO, Joint Force Headquarters and Deputy Commanding General - Support (DCG-S), 28th Infantry Division.

The deadline for local entries was a postmark of 01 December 2023. The national deadline was a postmark of 15 January 2024.

The theme for the contest this year was: "Causes of the American Revolutionary War."

Brother Sojourners,

During the months ahead, I hope to provide you with knowledge from the Constitution and Bylaws of the National Sojourner as well as the Constitution and Bylaws of Harrisburg Chapter #76. I will also share with you the Chapter's Policies and Procedures that have enabled this Chapter to excel in Membership, the Americanism programs, and Bridge of Light programs.

Here is the first bit of knowledge for all Brother Sojourners to know and understand.

The National Sojourners is incorporated as a nonprofit organization under Internal Revenue Code 501(c) 10, referred to as a "domestic fraternal Order".

At each monthly meeting the Purposes and Pronouncement of the National Sojourners is recited by one of our Chapter's elected officers. While the Purposes and Pronouncement are recited, do we really listen and comprehend these Purposes and Pronouncement?

These are the National Sojourners <u>Purposes and Pronouncement</u> as recited at our meetings and written in our National Constitution.

The <u>Purposes</u> of National Sojourners, shall be to organize current and former members of the uniformed forces of the United States and Honorary Members, who are Master Masons, into Chapters, for the promotion of good fellowship among its members, for assisting such as may be overtaken by adversity or affliction, for cultivating Masonic ideals, for supporting all patriotic aims and activities in Masonry, for developing true patriotism and Americanism throughout the nation, for bringing together representatives of the uniformed forces of the United States (past and present) in a united effort to further the military needs of National defense, and for opposing any influence whatsoever calculated to weaken the National security.

Pronouncement

National Sojourners believe in God as the Supreme Architect of the Universe. We hold that political, economic, and social problems are subsidiary to and ever separate from that steadfast belief in God. We maintain that God must motivate man if present day problems are to be solved, and we urge active participation in maintaining that Government for which our forefathers fought. Sojourners, remember that George Washington once said, "When we assumed the soldier, we did not lay aside the citizen."

Membership as address in Article III of the National Constitution

Membership in National Sojourners® is authorized only for citizens of the United States, who are Master Masons in good standing in any duly constituted Lodge of Master Masons, whose Grand Lodge is recognized by and maintains fraternal relations with the Grand Lodge member of the Conference of Grand Masters of Masons in North America and within whose jurisdiction the prospective member's Chapter is located.

Membership as address in Article III of the National Bylaws

ELECTION TO ACTIVE MEMBERSHIP:

Election to Active membership in an operational Chapter requires the Chapter Secretary to receive a duly completed, current Application for Membership; appropriate fees; and documented proof of United States citizenship, good standing as a Master Mason in a Lodge recognized by the Grand Lodge under whose authority the Chapter operates, and current service in or honorable discharge from the uniformed services. The Chapter Secretary must attest that all required documentation qualifies the applicant for Active membership <u>before he is duly elected and initiated</u>. (emphasis added)

ELECTION TO HONORARY MEMBERSHIP:

Election to Honorary membership in a Chapter requires U.S. citizenship and Master Mason status, certification by the Chapter President and Chapter Secretary that the Chapter is and <u>remains below the</u> 15% Honorary Member limit, and an affirmative, unanimous Chapter ballot. (emphasis added)

Harrisburg Chapter #76 Policy:

Since only candidates for Honorary Membership require an affirmative, unanimous Chapter ballot, and the normal attendance in a Harrisburg Chapter #76 meeting ranges from 60 to 80 members, the Chapter's Executive Committee performs the balloting by the customary "Masonic Ballot Box". If the candidate receives an affirmative, unanimous ballot for membership by the Executive Committee, the Chapter Secretary then presents the "Application for Membership" to the membership for election and initiation.
